

# Privacy Policy

This Website Privacy Statement applies to this website which is operated by Lendlease Development Malaysia Sdn Bhd under the domain name <http://theexchange.my> ("**Website**"), and the Company is part of the Lendlease Group, which also includes the operating entities which are listed at [www.lendlease.com](http://www.lendlease.com).

Information collected through the Website may be collected by any member of the Lendlease Group (referred to as "**we**", "**us**", "**our**"), which means Lendlease Corporation Ltd, its subsidiaries, affiliates and/or associated companies in accordance with this Website Privacy Statement. The Lendlease Group treats personal data with respect and integrity. Respect and integrity form part of our core values, which are the foundation for the conduct of the business in all parts of the globe. To that end we have published a Global Privacy Policy which can be viewed at [www.lendlease.com](http://www.lendlease.com). The Global Privacy Policy relates generally to the protection of personal data (being information which is capable of identifying an individual) and is applicable to the use of this Website, in addition to this Website Privacy Statement. This Website Privacy Statement explains how personal data will be treated as you access and interact with this Website.

We will post any changes to this Website Privacy Statement on the Website, so we encourage you to check this Website Privacy Statement from time to time. ## Information collected

Personal data about you which this Website may collect include:
